The cost is approximately £72.06 for individuals who receive payment from the club and £22.56. for volunteers. The BWF do not add any extra cost for this service. The DBS defines a volunteer as 'a person who is involved in an activity that requires time spent unpaid (apart from travel and other approved out-of-pocket expenses), with the aim of benefiting a third party other than or as well as a close relative.' **BWF will issue an invoice after the certificate has been issued.**
